| Discussion Items              | WVNEC Election for Four At-Large Representatives  We depend upon the Network Advisory Committee to oversee the content of our symposium, webinars and newsletters. We have four open spots up for election that the Network is holding over the Summer. You can nominate yourself or someone from your organization can nominate you as long as you or your institution is a current WVNEC member. Deadline to submit your nomination form and 250 word statement is June 30, 2015. A copy of the nomination form can be found in your packet.
